**10:10** Committee Leadership

*Under the PEP bylaws, Committee leadership is reviewed every two years.*

*The current Policy Committee Chair, representing the Suffolk County Executive, was recommended for reappointment for the 2025–2027 term.*

*All in favor, no members abstained, none opposed – Motion Approved*

**Action:** *MC recommendation for the approval of PEP Committee Leadership*

*Due to a vacancy in the New York State Department of Environmental Conservation, Division of Water and the need for additional internal review by Suffolk County Economic Development & Planning, the MC leadership recommendation was postponed.*

**Action:** *Table MC Leadership Appointment to January 2026 MC Meeting*

*Technical Advisory Committee (TAC) Leadership approval next term chair Matt Sclafani PhD., Vice-Chair Stephen Heck PhD.*

**Action:** *MC recommends TAC leadership to the Policy Committee for the next term (2025–2027) Dr Matt Sclafani, Cornell Cooperative Extension as Chair; Dr Stephen Heck, Stony Brook University as Vice-Chair*

*All in favor, no members abstained, none opposed – Motion Approved*

**10: 15** *PEP Seagrass Strategy; Joyce Novak, PhD, PEP Executive Director*

*Dr. Novak provided an overview of PEP's multi-year investment in seagrass research, including the bio-optical model work, new monitoring strategy, cold-water pocket mapping, and the regional coordination undertaken through the Coastal Watershed Grant. The update highlighted the shift toward science-based site suitability, regional collaboration, and the establishment of new long-term monitoring sites across the Peconics. Additional questions can be addressed by Jonathan Lefcheck PhD, UMCES*

PEP noted that further technical detail would be provided at the **November 5 TAC meeting** and offered a separate briefing for East Hampton due to meeting conflicts.

Javier Laureano, Policy Committee Member representing EPA, raised concerns regarding management of internal and external programmatic debates, referencing past scallop meeting debates as examples of how differing viewpoints can become contentious.

Javier introduced the following motion:

*“In order to continue to strengthen its partnerships with different organizations, the Policy Committee charges the PEP Executive Director with developing a Standard Operating Procedure to establish how to elevate to EPA and discuss internally key scientific, outreach, and other programmatic debates. This SOP should be presented, discussed, and approved by the Policy Committee within the next 120 days.*

The PC Chair asked if there was a second on the motion.

No second was offered by Policy Committee Members.

Following the lack of a second, the PC Chair Jennifer Juengst recommended tabling the motion, stating that new policy motions should be brought before the Policy Committee alone prior to presentation at a joint meeting.

Javier Laureano stated that EPA will discuss internally how to move this effort forward, independent of Policy Committee approval, through changes to the terms and conditions of all grants that PEP manages.

The PC Chair, Jennifer Juengst, logged an objection to the EPA representative’s final comment.

EPA Representative Javier Laureano closed with a note that EPA will discuss internally.

**10:45** Three years of PRB monitoring in East Hampton, Molly Graffam, PhD. Water Resource Geochemical Specialist, Cornell Cooperative Extension of Suffolk County

- Discussion of potential PEP Letter of Recommendation to expand this project.

Molly Graffam described well placement (150–250 feet landward of the shoreline), nitrogen reduction performance, and the need to evaluate deeper and more southerly wells in future phases.

*Molly Graffam requested support for the expansion of the project and asked whether PEP could provide either:*

- *a Letter of Support (LOS) for the expansion proposal, or, if PEP is unable to issue a LOS at this time,*
- *a letter stating that, if external funding is awarded through East Hampton water Quality Grant, PEP will work with CCE to develop a monitoring plan for the expanded scope.*

*Committee members acknowledged that only three of the five committed monitoring years have been completed and indicated that evaluation of any expansion should occur after the full dataset is available for review.*

*Timing was discussed, and if a letter is provided, it is needed by around March 2026, allowing adequate time for Committee review. Policy Committee's EPA representative stated that EPA will need to review the project before supporting any formal recommendation. Peconic Land Trust representative asked if this had been reviewed by the TAC. PEP Director responded that the project was presented to the TAC a few years back. TAC Chair Matt Sclafani emphasized the importance of the dataset and recommended bringing the findings and expansion proposal to TAC for technical review. PEP Director agreed and said the Program Office would use the January TAC meeting for this presentation. EPA Policy Committee rep Javier Lauraeno stated the EPA would need more time to review.*

**Action:** *The Committees agreed to table consideration of a letter of support or a conditional letter, and that PEP staff will circulate additional information and return the item to the Policy Committee following EPA and TAC review.*

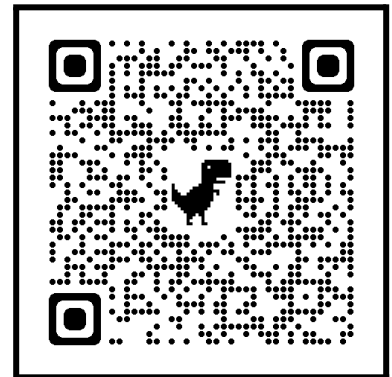
