Recap of the completed work under the PEP Mini Grant awarded to Cornell Cooperative Extension to conduct this work. Proposal to expand from this study utilizing the PEP FY25 NYS budget/PEP FY26 Workplan. This project will continue to use telemetry in tandem with isotope analysis to determine the interactions between diamondback terrapins and their environment.
